



**Directions:** Wantage Farm is situated about 2miles south west of Market Harborough and 10miles north of Kettering.

Heading West and South on A14 Esxit at Junction 3, head North on the A6 towards Market Harborough. At the Orton roundabout take the second exit to continue on the A6. At the next roundabout head straight towards the Baybrooke / Desborough roundabout take the first exit onto Desborough Road. Travel west on Desborough Road, pass through Baybrooke leading onto Harborough Road. In 0.7miles the farm entrance is situated on the right-hand side.



#### 1. Introduction

All Bidders and Buyers will be deemed to have read and accepted these terms and conditions prior to bidding. Our staff will be happy to help you if there is anything you do not fully understand.
- 1.2 Please refer to Clause 1 of the Conditions of Sale if you are unsure about the meaning of any defined term.
- 1.3 Except where the context otherwise requires words denoting the singular include the plural and vice versa. Words denoting one gender include all genders and words denoting persons include corporations and vice versa.
- 1.4 The Auctioneers may supplement or supersede these Conditions in whole or part with Special Conditions applicable to a specific sale or Lot which will be announced at the time of sale. No employee or agent of the Auctioneers has any authority to vary these Conditions.

#### 2. Buyers Premium

2.1 All purchases will be subject to a buyer's premium as follows:

Tractors and Vehicles – 6% + VAT All other items – 10% + VAT

The Buyer's Premium will be subject to a minimum charge of £2.50 plus VAT per Lot and to the Conditions below.

2.2 VAT at the standard rate will be charged on all charges except those detailed in 4.2 below.

#### 3. Entry to the Sale Site
